## NOTES - CONDITIONS OF CARRIER LICENCES

Under the *Telecommunications Act 1997* ('the Act') carrier licences are subject to the following conditions:

- (a) Section 61 of the Act provides that a carrier licence is subject to conditions specified in Schedule 1 to the Act.
- (b) Section 62 of the Act provides that a carrier licence is subject to the condition set out in section 152AZ of the *Competition and Consumer Act 2010*.
- (c) Section 63 of the Act provides that a carrier licence may be subject to any conditions declared by the Minister administering the Act including:
  - (i) conditions in addition to those referred to under sections 61 and 62 of the Act, applying to all carrier licences; and
  - (ii) conditions on specified carrier licences (the licences can be specified individually or by class).
