4 Transitional

The amendments made by Schedule 1 do not apply in relation to the following:

- (c) a complaint under the *Telecommunications Service Provider (Mobile Premium Services) Determination 2005 (No. 1)* that was made before the commencement of the amendments;
- (d) action taken, or proposed to be taken, under the *Telecommunications Service Provider (Mobile Premium Services) Determination 2005 (No. 1)* in relation to a complaint of that kind.
