Change of control notifications received by the ACMA for the period

This report only lists those persons ceasing and assuming control of a commercial broadcasting television or commercial broadcasting radio licence or associated newspaper in the reporting period.

The information contained in this document is based on notifications of changes in control provided to the ACMA by commercial television and commercial radio broadcasting licensees and publishers of associated newspapers, and persons assuming control of these licences and newspapers.

- Under section 63 of the Broadcasting Services Act 1992 (the BSA), if a commercial radio or television broadcasting licensee or an associated newspaper publisher becomes aware that a person has come to be, or has ceased to be, in a position to exercise control of the licence or newspaper, the licensee or publisher must notify the ACMA within 10 business days of becoming so aware.
- Under section 64 of the BSA, if a person has come to be in a position to exercise control of a commercial licence or associated newspaper (controller), they must notify the ACMA within 10 business days of becoming so aware.

These notifications are to be provided in the approved form: the ACMA B2/B3 Form.

The ACMA is required to maintain a register of these notifications under section 75 of the BSA. Copies of, or an extract from, any entry in the register (including those that predate the reporting period) will be made available on request. Contact control@acma.gov.au.
