

SENATE ORDER ON DEPARTMENTAL AND AGENCY CONTRACTS LISTING FOR THE PERIOD 01 JANUARY 2019 TO 31 DECEMBER 2019¹

Pursuant to the Senate Order on departmental and agency contracts the following table sets out grant agreements entered into by the Australian Communications and Media Authority which provide for a consideration to the value of \$100,000 (GST inclusive) or more which:

- a. have not been fully performed as at 31 December 2019, or
- b. which have been entered into during the 12 months prior to 31 December 2019.

All grant agreements listed contain confidentiality provisions of a general nature that are designed to protect confidential information of the parties that may be obtained or generated in carrying out the agreement. The reasons for including such clauses include:

- ordinary commercial prudence that requires protection of trade secrets, proprietary information and the like, and/or
- protection of other Commonwealth material and personal information.

Where the Australian Communications and Media Authority has agreed that specific matters associated with a contractual arrangement are to be treated as confidential, this is indicated in the listing.
