- No action will be taken if both signatures are not recorded.
- From 1 January 2026, persons will be required to notify the Australian Competition and Consumer Commission (the ACCC) of certain acquisitions if the persons or acquisitions meet specified thresholds and must wait to receive approval before

the acquisition can proceed. This may include the assignment of a spectrum licence if the specified thresholds are met. For more information please see the [ACCC's information on merger reforms](#).
